Countermotion on agenda item 3, No. 2

On May 24, 2017, the ordinary general meeting of the company is scheduled to be held, to which you expressed an invitation by promulgation in the German Federal Gazette of April 11, 2017 and the agenda of which you amended on May 24, 2017. Our client will attend this annual general meeting itself as a shareholder of your company or represented by proxy and thus meet the prerequisites for exercising its right to vote. Our client will contest the proposal by the Executive Board and Supervisory Board on agenda item 3 and submit the following countermotion:

REASONS:

In your statement regarding the addendum to the agenda, you and your CEO Hartmut Müller expressed the untrue claim that our proposed resolution for the election of Supervisory Board members was in violation of Section 96 para. 2 of the German Stock Corporation Act (AktG). You failed to mention that you had amended agenda item 7 of your own volition, amending the requested agenda item "Election of Supervisory Board members" to read as follows: "Resolution regarding the new election of three Supervisory Board members" and including it as such on the agenda. In addition, you neglected to mention that our client intends to discharge five and not only three Supervisory Board members; the reasons for this are stated in our countermotion on agenda item 4. The reason for this maneuver is quite obvious: Quite evidently, in case five Supervisory Board members are discharged pursuant to Section 104 of the German Stock Corporation Act (AktG) the Executive Board plans to have the incomplete Supervisory Board filled by court appointment, due to the legally disallowed restriction of the agenda item, with candidates acceptable to the Executive Board. In actual fact, our client had and still has two suitable candidates at its disposal whom it will nominate in supplementation at the Annual General Meeting, namely Ms. Esada Karovic and Ms. Franziska Jaensch. We attach their resumes in the Annex. The "clandestine" attempt to prevent the decision concerning the full membership of the stockholder side at the Annual General Meeting and to continuing to "reign" together with the employee representatives on the Supervisory Board in this way is not only obviously unlawful but will inevitably lead to an extraordinary general meeting to be convened at short notice, the costs of which you and Mr. Müller will have to bear personally because you made this additional extraordinary general meeting necessary by unilaterally amending the agenda item we requested. This rules out the ratification of your actions and renders this countermotion inevitable.
